# **EXECUTIVE SUMMARY**

The Health Resources and Services Administration (HRSA), Bureau of Health Workforce, Division of Nursing and Public Health is accepting applications for the fiscal year (FY) 2018 Nurse Anesthetist Traineeship (NAT) Program. The purpose of this program is to support eligible entities to meet the cost of traineeships for individuals in nurse anesthesia degree programs. Grants are awarded to accredited institutions that educate registered nurses to become nurse anesthetists; recipient institutions, in turn, disburse funds to students in the form of traineeship support. NAT students may use traineeship funds during the period for which the traineeship is provided for full or partial costs of the tuition and fees, books/e-books, reasonable living expenses (stipends) and to attend workshops or conferences on topics including, but not limited to, reduced opioid use disorder, multi-modal pain management, and enhanced recovery. The funds appropriated for the NAT Program are distributed among all eligible applicant institutions based on a formula. The FY 2018 President's Budget does not request funding for this program. This notice is a contingency action taken to ensure that, should funds become available for this purpose, applications can be processed, and funds awarded in a timely manner. Applicants should note that this program may be cancelled prior to award recommendations.

# I. Program Funding Opportunity Description

#### 1. Purpose

This notice solicits applications for the fiscal year (FY) 2018 Nurse Anesthetist Traineeship (NAT) Program.

#### Program Purpose

The purpose of this program is to support eligible entities to meet the cost of traineeships for individuals in Nurse Anesthesia degree programs. Nurse Anesthetists are on the front lines of the opioid epidemic, especially in rural areas, where they are often the sole provider of anesthesia services. As part of their training, these individuals learn about multi-modal pain management and opioid addition and treatment, which are a key part of helping communities address the opioid crisis.

Grants are awarded to accredited institutions that educate registered nurses to become nurse anesthetists; recipient institutions, in turn, disburse funds to students in the form of traineeship support. The funds for the NAT Program are distributed among all eligible applicant institutions based on a formula.

This funding opportunity will help address U.S. Department of Health and Human Services' (HHS) clinical priority of addressing opioid abuse by providing funds to support Student Registered Nurse Anesthetists (SRNAs) training or continuing education related to pain management, opioid abuse prevention and treatment. SRNAs may use traineeship funds during the period for which the traineeship is provided for full or partial costs of the tuition and fees, books/e-books, reasonable living expenses (stipends) and to attend workshops or conferences on topics including, but not limited to, reduced opioid abuse, multi-modal pain management, and recovery.

#### Program Requirements

Successful applicants will be required to conduct the following activities:

- 1. **Identify eligible students** enrolled in its accredited, full-time graduate-level nurse anesthesia degree programs;
- Provide traineeship awards to those eligible students (minimum \$1,000 and maximum \$22,000 per student) consistent with terms outlined in Section II.2 (Summary of Funding); and
- 3. Collect and report student and graduate-level data to allow for accurate and timely reporting of required performance measures.

#### Funding Preference

As authorized by Section 805 of the Public Health Service Act (42 U.S.C. § 296d), funding preference shall be given to applicants with projects that will substantially benefit rural or underserved populations, or help meet public health nursing needs in State or local health departments.

To be considered for the Statutory Funding Preference, you must supply all supporting data in the NAT Program Specific Data Forms (Table 2). Refer to Section *V.2* of this funding opportunity for additional guidance on this funding preference.

#### **Special Consideration**

As authorized by Section 811(g)(2) of the Public Health Service Act (42 U.S.C. § 296j(g)(2)), special consideration shall be given to an eligible entity that agrees to expend the award to train advanced education nurses who will practice in health professional shortage areas (HPSAs).

To be considered for the Special Consideration, you must supply all supporting data in the NAT Program Specific Data Forms (Table 2). Refer to Section V.2 of this funding opportunity for additional guidance on this statutory funding factor.

#### 2. Background

#### Legislation

This program is authorized by Title VIII, Section 811(a)(2) of the Public Health Service Act, (42 U.S.C. 296j(a)(2)).

# Role of Certified Registered Nurse Anesthetists (CRNAs) in addressing opioid abuse in rural areas

HRSA strives to improve health and achieve health equity by strengthening the health workforce and connecting skilled professionals to communities in need. In October 2017, the President declared a public health emergency to address the national opioid crisis.<sup>1</sup> According to the American Society of Addiction Medicine, 1.9 million Americans age 12 and older had a substance use disorder.

While every state in the nation has been impacted by this epidemic, rural states such as New Hampshire, Kentucky, Ohio, and West Virginia are most affected.<sup>2,3</sup> CRNAs are at the frontline of the opioid crisis because they are more likely to practice in rural areas where the opioid crisis is most acute. In fact, CRNAs are the sole anesthesia providers in more than many rural hospitals in the United States.

Nurse Anesthesia programs including training students in a holistic approach to pain management and patient care to prevent drug overdoses and death, opioid abuse and substance use disorder.<sup>4</sup> This can include training in multimodal pain management providing "a range of multiple and different types of therapies that may include medical,

surgical, psychological, behavioral, and integrative approaches as needed."<sup>5</sup> In addition, these programs regularly use tools like the Substance Abuse and Mental Health Services Administration (SAMHSA) Providers' Clinical Support System For Opioid Therapies in supporting the training of the Nurse Anesthesia students.<sup>6</sup>

By educating and providing clinical training for NAT students in opioid addiction management and treatment, the NAT award recipients will be supporting HHS's priority to combat the opioid abuse epidemic.

#### 3. Program Definitions

The following definitions apply to the NAT Program for Fiscal Year 2018.

- 1. **New Funding Opportunity Type** is an application that is being submitted to HRSA for the first time and has not previously received an NAT award.
- 2. **Competing Continuation Funding Opportunity Type** is an application or an award made for additional funding/budget period for a project with a projected completion date, through a competing process.
- 3. Health Professional Shortage Areas (HPSAs)<sup>7</sup> is a federal designation used to identify areas, populations, and facilities, which have a shortage of either primary care, dental, and/or mental health providers as measured by the ratio of available discipline-specific providers to: the population of the area; a specific population group; or the number of those served by the facility. All federally qualified health centers and rural health clinics, as defined in section 1861(aa) of the Social Security Act (42 U.S.C. 1395x(aa)) and that meet the requirements of section 334 in PHSA, (related to charging for services,) shall be automatically designated as having such a shortage. - 4. **New Appointment** means the appointment of a student to receive NAT funds during the current budget/project year who has not received NAT support during any previous budget/project period.
- 5. **Reappointment** means any appointment of a student to receive NAT funds during the current budget/project year who has received NAT support during any previous budget/project period(s).
- 6. **Rural area**<sup>8</sup> is a geographical area located in a non-metropolitan county, or an area located in a metropolitan county designated by the Federal Office of Rural Health Policy as being considered rural.
- 7. **Underserved Area** is a geographic location or population of individuals that is eligible for designation by the federal government as a Health Professional Shortage Area, Medically Underserved Area, Medically Underserved Population, or Governor's Certified Shortage Area for Rural Health Clinic purposes. As an umbrella term, Medically Underserved Community (MUC) also includes populations such as

## II. Award Information

#### 1. Type of Application and Award

Type(s) of applications sought: New and Competing Continuation

Funding will be provided in the form of a grant.

#### 2. Summary of Funding

Approximately \$4,850,000 is expected to be available in FY 2018 to fund approximately eighty (80) recipients. Awards will be distributed among all eligible institutions based on a formula calculation using data supplied by applicants in the NAT Program Specific Data Forms (see appendix). *Applicants that fail to submit this information will not be considered for funding.* The actual amount available will not be determined until enactment of the final FY 2018 federal appropriation. The FY 2018 President's Budget does not request funding for this program. This program notice is subject to the appropriation of funds, and is a contingency action taken to ensure that, should funds become available for this purpose, applications can be processed, and funds can be awarded in a timely manner. Current recipients of an NAT award must submit a New/Competing Continuation application (see program definitions in Section VIII) for each annual open competition to be considered for funding beyond the previous project period.

The project period is July 1, 2018 through June 30, 2019 (1 year).

Allowable costs are limited to traineeship support only, with a minimum award amount of \$1,000 per student and not to exceed \$22,000 per student. A trainee may be appointed at the beginning of any academic period, including summer session, which falls within the budget period specified by the current Notice of Award (NOA).

Traineeship support may cover the following:

- Full or partial tuition and fees;
- Stipends, i.e., reasonable living expenses; and
- Required textbooks (including e-Books).

All HRSA awards are subject to the Uniform Administrative Requirements, Cost Principles and Audit Requirements at <u>45 CFR part 75</u>.

Indirect costs are not authorized under this award.

# III. Eligibility Information

#### 1. Eligible Applicants

Eligible applicants are schools of nursing, nursing centers, academic health centers, State or local governments, and other public or private nonprofit entities determined appropriate by the Secretary.

Foreign entities are not eligible for this HRSA award.

Individuals are not eligible to apply to the NAT Program funding opportunity.

Any school(s) of nursing affiliated with this application must be accredited to provide graduate nurse anesthesia education at the time of application – and for the duration of the award – by the Council on Accreditation of Nurse Anesthesia Educational Programs. Applicants must submit official documentation of accreditation in **Attachment 1** for all affiliated nursing programs. Applicants who fail to submit accreditation documentation **will be considered nonresponsive and deemed ineligible under this funding announcement**.

In addition to the 50 states, the District of Columbia, Guam, the Commonwealth of Puerto Rico, the Northern Mariana Islands, American Samoa, the U.S. Virgin Islands, the Federated States of Micronesia, the Republic of the Marshall Islands, and the Republic of Palau may apply. Tribes and Tribal organizations may apply for these funds, if otherwise eligible.

#### 2. Cost Sharing/Matching

Cost sharing/matching is not required for this program.

#### 3. Other

#### **Due Date**

Any application that fails to satisfy the deadline requirements referenced in *Section IV.4* will be considered non-responsive and will not be considered for funding under this notice.

#### Maintenance of Effort (MoE)

The recipient must agree to maintain non-federal funding for award activities at a level which is not less than expenditures for such activities during the fiscal year prior to receiving the award, as required by Section 803(b) of the Public Health Service Act. Complete the Maintenance of Effort document and submit as **Attachment 2**.

#### **Multiple Applications**

Multiple applications from an organization are not allowable; however, applicants can submit one application per campus (must have unique DUNS numbers). A campus is defined as a division of a university that has the same name yet is separate with its own grounds, buildings (e.g., school of nursing) and faculty. For example, the University of Homestate at Smalltown and the University of Homestate at Anytown can each submit an application for this program.

If for any reason (including submitting to the wrong funding opportunity number or making corrections/updates), an application is submitted more than once prior to the application due date, HRSA will only accept your last validated electronic submission, under the correct funding opportunity number, prior to the Grants.gov application due date as the final and only acceptable application.

#### **Beneficiary Eligibility Requirements**

To receive NAT traineeship support from a recipient institution, an individual must be

- Enrolled full-time in an accredited course of study leading to a graduate degree in nurse anesthesia and
- A citizen of the United States, a non-citizen national, or a foreign national having in his/her possession a visa permitting permanent residence in the United States.
- Eligible to sit for the certification examination administered by the American Association of Nurse Anesthetists Council on Certification of Nurse Anesthetists to become a Certified Registered Nurse Anesthetist upon program completion.

NOTE: Individuals on temporary student visas are <u>not eligible</u> to receive NAT traineeship support.

#### Length of Support

- A trainee may be appointed at the <u>beginning of any academic period</u>, including a summer session, which falls within the budget period specified by the current Notice of Award (NoA).
- Any new appointment (see program definitions in Section VIII) must be made for a period of not fewer than nine months and not to exceed a period of 12 months. The only exception to the minimum appointment is to allow a student to complete the program.
- Trainees may receive a **reappointment** (see program definitions in Section VIII).
- The cumulative traineeship support may not exceed 36 months and must be continuous from the start of the initial appointment.

#### **Completeness and Eligibility**

Failure to include all required documents as part of the application may result in an application being considered incomplete or non-responsive. Applications received without the appropriate tables will be considered non-responsive to the NOFO and will not be considered for funding under this notice.

# **IV.** Application and Submission Information

#### 1. Address to Request Application Package

HRSA *requires* you to apply electronically through Grants.gov. You must download the SF-424 Research and Related (R&R) application package associated with this NOFO following the directions provided at <u>https://www.grants.gov/applicants/apply-for-grants.html</u>.

**Effective December 31, 2017** – You **must** use the <u>Grants.gov Workspace</u> to complete the workspace forms and submit your application workspace package. After this date, you will no longer be able to use PDF Application Packages.

#### 2. Content and Form of Application Submission

Section 4 of HRSA's <u>SF-424 R&R Application Guide</u> provides instructions for the budget, budget justification, staffing plan and personnel requirements, assurances, certifications, and abstract. For the NAT Program, budgets and staffing plans are not required. You must submit the information outlined in the <u>SF-424 R&R Application Guide</u> in addition to the program specific information below. You are responsible for reading and complying with the instructions included in HRSA's <u>SF-424 R&R Application Guide</u> except where instructed in the NOFO to do otherwise. Applications must be submitted in the English language and must be in terms of U.S. dollars (45 CFR § 75.111(a)).

See Section 8.5 of the <u>SF-424 R&R Application Guide</u> for the Application Completeness Checklist.

#### **Application Page Limit**

The total size of all uploaded files should not exceed the equivalent of **30 pages** when printed by HRSA. The page limit includes the abstract, project narrative, attachments including biographical sketches (biosketches), and letters of commitment and support required in HRSA's *SF-424 R&R Application Guide* and this NOFO. For the NAT Program, letters of commitment and support are not required. Standard OMB-approved forms that are included in the application package do NOT count in the page limitation. Applicants that qualify for the preference will receive a favorable financial adjustment of the NAT formula used to ultimately determine the amount of the NAT award. Applications that do not receive a funding preference will receive full and equitable consideration during the review process.

#### **Special Consideration**

This program includes special consideration as authorized by Section 811(g)(2) of the Public Health Service Act (42 U.S.C. § 296j(g)(2)) an eligible entity that agrees to expend the award to train CRNA who will practice in Health Professional Shortage Areas (HPSAs), as designated under PHS Act Section 332. Qualified applicants will demonstrate a high rate of graduates from the preceding academic year (AY) 2016-17 currently employed in HPSAs, as calculated based on data supplied in the NAT Program Specific Data Forms.

For the purpose of this funding announcement, "high rate" is defined as a **minimum of 60 percent of graduates** in AY2016-17 employed in HRSA-designated HPSAs.
