EXECUTIVE SUMMARY

The Health Resources and Services Administration (HRSA) is accepting applications for fiscal year (FY) 2019 for the Newborn Screening State Evaluation Program. The purpose of this program is to evaluate the effectiveness of newborn screening programs in reducing the morbidity and mortality caused by heritable disorders in newborns and children by assessing the timeliness of screening, follow up, and referral to counseling or health care services. The program will support state newborn screening programs in the implementation of a demonstration program to use newborn screening quality indicator information to evaluate the effectiveness of their state newborn screening system.

I. Program Funding Opportunity Description

1. Purpose

This notice solicits applications for the Newborn Screening State Evaluation Program.

The purpose of this program is to collect data in order to improve evaluation of state newborn screening programs and to build state-level capacity to assess and report on the effectiveness of screening, including timeliness, follow up, counseling, and health care services, in reducing the morbidity and mortality caused by heritable disorders in newborns and children. This demonstration program will evaluate the effectiveness of state newborn screening systems by collecting data on newborn screening quality indicator information. Quality indicators, determined by the HRSA-funded Newborn Screening Technical Assistance and Evaluation Program (NewSTEPs), cover actions within the newborn screening system including assessing false-positive rates, borderline results, screening of eligible newborns, specimen collection time and transport rates, and time of medical intervention. They provide longitudinal comparisons within newborn screening programs and aggregate data at a national level. By building state level data capacity to evaluate their newborn screening processes, states will identify gaps and challenges within their systems. Data will inform state programs on the validity of newborn screening results: whether infants with heritable disorders are being diagnosed and treated in a timely manner, and receiving proper follow-up counseling and healthcare services. This will ultimately, improve health outcomes for children with heritable disorders.

Program Objectives

Recipients will be responsible for collecting data on the objectives below for the purposes of monitoring and evaluating the overall effectiveness of the Newborn Screening State Evaluation Program.

Objectives:

By 2021, all available data¹ on NewSTEPs quality indicators for all newborns screened in 2019–2020 will be collected and submitted to a national newborn screening data repository; and

By 2021, participating states will have an established sustainability plan to support data collection activities beyond the period of performance.

2. Background

This program is authorized by the Public Health Service Act, § 1110 (42 U.S.C. 300b-9) to conduct demonstration programs to evaluate the effectiveness of screening, including timeliness, follow up, counseling, and health care services. The overall program impact

is reducing the morbidity and mortality caused by heritable disorders in newborns and children.

Newborn screening is an effective state and territorial public health program that saves and improves the lives of thousands of babies each year in the United States. Four million newborns each year are screened for at least 35 core conditions on the Recommended Uniform Screening Panel, a list of conditions adopted by the Secretary of Health and Human Services and recommended for screening in state newborn screening programs. These conditions require early screening, intervention, and treatment to mitigate brain and organ damage, severe illness, and/or life-threatening complications associated with these conditions.

States will collaborate closely with NewSTEPs to develop and implement policies, procedures, and methods to measure their performance in the newborn screening system. Funded since 2012, NewSTEPs has standardized national newborn screening quality measures used by state newborn screening programs and allowed for consistent categorization at the local, regional, and national levels of newborns identified though the newborn screening system.

This funding will support state efforts in the evaluation and assessment of their state newborn screening systems and identify best practices, gaps and/or challenges. It is important for states to evaluate their programs to ensure that children who need services are receiving them in a timely manner due to the time-sensitive nature of the conditions. In addition, the information will help NewSTEPs assess the utility of the quality indicators and update them, if necessary, to support state efforts in evaluating their programs.

II. Award Information

1. Type of Application and Award

Type(s) of applications sought: Competing continuation, New

HRSA will provide funding in the form of a grant.

2. Summary of Funding

HRSA expects approximately \$2,250,000 to be available annually to fund up to 15 recipients. You may apply for a ceiling amount of up to \$150,000 total cost (includes both direct and indirect, facilities and administrative costs). The period of performance is September 1, 2019 through August 31, 2021 (2 years). Funding beyond the first year is subject to the availability of appropriated funds for the Newborn Screening State Evaluation Program in subsequent fiscal years, satisfactory recipient performance, and a decision that continued funding is in the best interest of the Federal Government.

All HRSA awards are subject to the Uniform Administrative Requirements, Cost Principles and Audit Requirements at <u>45 CFR part 75</u>.

III. Eligibility Information

1. Eligible Applicants

Eligible applicants include states or political subdivisions of a state or a consortium of two or more states or political subdivisions of states.

2. Cost Sharing/Matching

Cost sharing/matching is not required for this program.

3. Other

HRSA will consider any application that exceeds the ceiling amount non-responsive and will not consider it for funding under this notice.

HRSA will consider any application that fails to satisfy the deadline requirements referenced in *Section IV.4* non-responsive and will not consider it for funding under this notice.

NOTE: Multiple applications from a state are not allowable.

If for any reason (including submitting to the wrong funding opportunity number or making corrections/updates) an application is submitted more than once prior to the application due date, HRSA will only accept your **last** validated electronic submission, under the correct funding opportunity number, prior to the Grants.gov application due date as the final and only acceptable application.

Program Requirements

- 2) Collaborate with NewSTEPs to develop and implement policies, procedures, and methods to enter information and provide feedback on all quality indicators to measure performance of newborn screening, such as false-positive rates and other quality indicators as established by the Newborn Screening Data Repository and Technical Assistance Program.
- Develop benchmarks that can be achieved by 6, 12, and 18 months to ensure that the program objectives are achieved by the end of the period of performance (24 months).
- 4) Enter all available data on all newborns screened from 2019–2020 into the NewSTEPs data repository for the purposes of evaluation and assessment of your state's newborn screening program. States will work with the data repository on available options for data transfer including using electronic data exchange or other data transfer capabilities.
- 5) Provide feedback to NewSTEPs on the usefulness of the measures and reports to evaluate your programs.
- 6) Establish a sustainability plan that addresses how evaluation efforts will be sustained after federal funding ends and how data collection will become a standard practice within the newborn screening program.
- 7) Collaborate, coordinate, and link to other systems and stakeholders with data that support the newborn screening system, including Title V programs, birthing hospitals, clinicians, vital records, early intervention, etc., in order to assess the effectiveness of screening, treatment, counseling, testing, follow-up and specialty services for newborns and children at risk for heritable disorders.

A well-documented progress report is a required and important source of material for HRSA in preparing annual reports, planning programs, and communicating program-specific accomplishments. The accomplishments of competing continuation applicants are carefully considered; therefore, you should include previously stated goals and objectives in your application and emphasize the progress made in attaining these goals and objectives. HRSA program staff reviews the progress report after the Objective Review Committee evaluates the competing continuation applications.

3. Dun and Bradstreet Data Universal Numbering System (DUNS) Number and System for Award Management

The due date for applications under this NOFO is *May 6, 2019 at 11:59 p.m. Eastern Time*. HRSA suggests submitting applications to Grants.gov at least **3 days before the deadline** to allow for any unforeseen circumstances.

6. Funding Restrictions

You may request funding for a period of performance of up to 2 years, at no more than \$150,000 per year (inclusive of direct **and** indirect costs).

The General Provisions in Division B of the Department of Defense and Labor, Health and Human Services, and Education Appropriations Act, 2019 and Continuing Appropriations Act, 2019 (P.L. 115-245) apply to this program. Please see Section 4.1 of HRSA's <u>SF-424 Application Guide</u> for additional information. Note that these or other restrictions will apply in the following FY, as required by law.

These criteria are the basis upon which the reviewers will evaluate and score the merit of the application. The entire proposal will be considered during objective review. Applications submitted for this program will be reviewed by external peer reviewers using a Field Review method. Reviewers will rate each sub-criterion listed below as a strength, weakness, or as meeting requirements. Points will be assigned as listed for each criterion, for a maximum of 100 points per application.

Review criteria are used to review and rank applications. The Newborn Screening State Evaluation Program has six review criteria:

Criterion 1: NEED (15 points) – Corresponds to Section IV's Introduction and Needs Assessment

- Does the application outline the needs of the organization with respect to reporting newborn screening data to the Newborn Screening Data Repository (NewSTEPs), including the extent to which it will be unable or limited in its capacity to report data absent receipt of funds?
- Does the application describe and document the state's (or states') existing newborn screening program's current data reporting capacity?
- Does the application discuss any relevant barriers to data collection and reporting that the project hopes to overcome through this funding opportunity?

Criterion 2: RESPONSE (30 points) – Corresponds to Section IV's Methodology, Work Plan, and Resolution of Challenges

Methodology (15 points)

The strength, completeness, and feasibility of the applicant's:

- Proposed project and its alignment with the purpose of this NOFO.
- Use of data whenever possible to support the information provided.

This includes the extent to which the applicant:

- Proposes a project that responds to the "Purpose" included in the program description.
- Describes plans to enter into a data use agreement with the Newborn Screening Data Repository and Technical Assistance Program established under HRSA-18-080 to submit newborn screening data and information about their newborn screening program into the repository.
- Describes plans to collaborate with the Newborn Screening Data Repository and Technical Assistance Program to develop and implement policies, procedures, and methods in order to enter information on quality indicators to measure performance of newborn screening, such as false-positive rates and other quality indicators as established by the Newborn Screening Data Repository and Technical Assistance Program.
- Describes plans to enter quality indicator data on all newborns screened in 2019–2020 into the Data Repository.
- Describes plans to establish a sustainability plan to ensure data is collected and reported to the Newborn Screening Data Repository beyond the period of performance.
- Describes plans for collaborating, coordinating, and linking to other databases that support the newborn screening system, including Title V programs, birthing hospitals, clinicians, vital records, early intervention, etc.
- Identifies and describes benchmarks that can be achieved by 6, 12, and 18 months to ensure that the program objectives are achieved by the end of the period of performance (24 months)
- For applicants that were previously funded under HRSA-18-125: Describes how the project will build on (and not duplicate) activities funded under HRSA-18-125.

Work Plan (10 points)

The extent to which the applicant:

- Describes the activities or steps that will be used to achieve each of the objectives proposed during the period of performance.
- Includes a time line that includes each activity and identifies responsible staff.
- Identifies meaningful support and collaboration with key stakeholders in planning, designing and implementing all activities.
- Includes the 6, 12, and 18-month benchmarks as explained above.

Resolution of Challenges (5 points)

The extent to which the applicant:

• Describes the challenges that the applicant is likely to encounter in designing and implementing the work plan and approaches that will be used to resolve such challenges.

Criterion 3: EVALUATIVE MEASURES (10 points) – Corresponds to Section IV's Evaluation and Technical Support Capacity

- Does the application propose a method to monitor and evaluate the project results?
- Do the evaluative measures assess: 1) to what extent the program objectives have been met, and 2) to what extent these can be attributed to the project?
- Does the application include the 6, 12, and 18-month benchmarks to be achieved by the end of the period of performance (24 months).

Criterion 4: IMPACT (10 points) – Corresponds to Section IV's Work Plan

- Does the application have a work plan with activities that are feasible to address the evaluation needs of the state newborn screening program?
- For applicants that were previously funded under HRSA-18-125: Does the application describe how the project will build on (and not duplicate) activities funded under HRSA-18-125?

Criterion 5: RESOURCES/CAPABILITIES (20 points) – Corresponds to Section IV's Evaluation and Technical Support Capacity and Organizational Information

The extent to which the applicant:

- Describes the training and/or experience that qualifies project personnel to implement and carry out the project.
- Describes the capabilities of the organization and the quality and availability of facilities and personnel to fulfill the needs and requirements of the proposed project.
- Describes the organization's mission and structure, scope of current activities, including an organizational chart, and describes how these elements all contribute to the organization's ability to conduct the program requirements and meet program expectations.
- Describes how the organization will follow the approved plan, as outlined in the application, properly account for the federal funds, and document all costs as to avoid audit findings. For applicants that were previously funded under HRSA-18-125: Describes how the project will build on (and not duplicate) activities funded under HRSA-18-125.

Criterion 6: SUPPORT REQUESTED (15 points) – Corresponds to Section IV's Budget and Budget Narrative

- Is the proposed budget reasonable for the period of performance in relation to the program goal, purpose, and requirements?
- Are the costs in the budget sections reasonable, given the scope of work?
- Do the key personnel have adequate time devoted to the project to achieve project objectives?

2. Review and Selection Process

The independent review process provides an objective evaluation to the individuals responsible for making award decisions. The highest ranked applications receive consideration for award within available funding ranges. HRSA may also consider assessment of risk and the other pre-award activities described in Section 3 below.

3. Assessment of Risk and Other Pre-Award Activities

HRSA may elect not to fund applicants with management or financial instability that directly relates to the organization's ability to implement statutory, regulatory or other requirements (<u>45 CFR § 75.205</u>).

HRSA reviews applications receiving a favorable objective review for other considerations that include past performance, as applicable, cost analysis of the project/program budget, assessment of your management systems, ensuring continued applicant eligibility, and compliance with any public policy requirements, including those requiring just-in-time submissions. HRSA may ask you to submit additional programmatic or administrative information (such as an updated budget or "other support" information) or to undertake certain activities (such as negotiation of an indirect cost rate) in anticipation of an award. However, even at this point in the process, such requests do not guarantee that HRSA will make an award. Following review of all applicable information, HRSA's approving and business management officials will determine whether HRSA can make an award, if special conditions are required, and what level of funding is appropriate.

Award decisions are discretionary and are not subject to appeal to any HRSA or HHS official or board.

HRSA will report to FAPIIS a determination that an applicant is not qualified (<u>45 CFR §</u> <u>75.212</u>).

b) Performance Reporting Timeline

Successful applicants receiving HRSA funds will be required, within 120 days of the period of performance start date, to register in HRSA's EHBs and electronically complete the program-specific data forms that are required for this award.
